

Exhibitor Policy for MACMH Conferences and Trainings

At MACMH, we value the partnerships we build with exhibitors who play a vital role in our conferences and training events. To ensure a positive and productive experience for all participants, please review and adhere to the following exhibitor policy:

1. Eligibility and Acceptance

- Eligibility: Only organizations and individuals with products or services relevant to our conference's focus on children's mental health are eligible to exhibit.
- Acceptance: Exhibitor applications are subject to review and approval by MACMH. Submission of an application does not guarantee acceptance.

2. Registration

- All exhibitors must register for the conference or training event separately from the exhibitor fee. Registration fees for exhibitors are not included in the exhibit space fee.

3. Payment and Cancellation

- Payment: Exhibitor fees are due upon acceptance of your application. Payment can be made through our online registration system.
- Cancellation: Cancellations must be made in writing and are subject to a cancellation fee. Please refer to our cancellation policy for details.

4. Exhibit Space

- Booth Assignment: Booth assignments are made by MACMH and are non-transferable.
- Space Usage: Exhibitors must use their designated space only and may not encroach on neighboring booths or common areas.

5. Set-Up and Tear-Down

- Set-Up: Exhibitors may set up their booths during the designated set-up hours. Early set-up or late tear-down is not permitted.
- Tear-Down: Exhibitors must remove all materials and leave the booth area clean at the end of the event.

6. Conduct and Decorum

- Professionalism: Exhibitors must conduct themselves in a professional manner at all times.
- Noisy Equipment: Exhibitors should avoid using loud equipment that may disrupt neighboring booths or presentations.

7. Marketing and Promotions

- Materials: Promotional materials should be respectful and appropriate for our audience.
- Contests and Giveaways: Exhibitors are encouraged to host contests or giveaways, but they must comply with all local, state, and federal laws.



8. Harmful or Discriminatory Practices

- Disqualification: Exhibitors with practices that promote harm, discrimination, or prejudice will be disqualified from participating in our events.

9. Liability and Insurance

- Liability: Exhibitors are responsible for their own liability insurance. MACMH is not responsible for loss or damage to exhibitor materials.

10. Compliance with Policy

- Compliance: Exhibitors must comply with all MACMH policies and the policies of the venue hosting the event.

11. Enforcement

- MACMH reserves the right to enforce this policy and may take appropriate action, including eviction from the event, for non-compliance.
